1. Call to Order

Chairman Sauble called the meeting to order at 9:02 a.m.

8. Discuss/Approve – Indigent Care Claims

Indigent Care Coordinator Mary Alice Gutierrez presented the Indigent Care Claims for June 2018. Previously Approved Claims: Case #2018-07 for a total of \$144.58, VMDC Claims: Case #2018-08 thru #2018-11 for a total of \$6,167.06, Sheriff Claims: Case #2018-12 thru #2018-16 for a total of \$4,652.03, and New Applicants: Claim #2018-17 thru #2018-19 for a total of \$7,218.55. There were no denied claims. Previously Approved Claims: MCMC \$16,567.74 for Hospital Services, ARIS \$126.00 for Radiology Services, Women's Medical Center \$945.20 for Clinic Services, and City of Raton \$513.28 for Ambulance Services for a sub-total of \$18,152.22. The 2017-2018 non-MCMC Claim total is \$1,584.48.
