8. Discuss/ Approve - Indigent Care Claims

10. Discuss/Action – Juvenile Detention Contract Renewal for Colfax County with Taos County

County Manager Kern stated that this renewal contract is between Colfax County and Taos County from which at times Colfax County will need to send Juvenile residents to their facility. The contract will be effective for a term of 1 year and will expire on June 30, 2017.

Commissioner Fernandez made motion to approve the Juvenile Detention contract Renewal for Colfax County with Taos County. Commissioner Newton seconded the motion. The motion carried unanimously.

11. Discuss/Action – Partnership Agreement between the Fire Marshal Division of the Public Regulation Commission and Local Governments Operating New Mexico Certified Fire Departments

Larry Osborn, Fire Marshal for Colfax County stated this agreement application between the Public Regulation Commission's Fire Marshal Division, and the NM Municipal and County Fire Departments. The purpose is to allow fire departments the opportunity to provide various aspects of fire prevention and protection by conducting and/or assisting the State Fire Marshal Division with fire code inspections and origin and cause investigations, when deemed beneficial to both parties.

Commissioner Sauble made motion to approve Partnership Agreement between the Fire Marshal Division of the Public Regulation Commission and Local Governments Operating New Mexico Certified Fire Departments. Commissioner Newton seconded the motion. The motion carried unanimously.

12. Discuss/Action – Review Resolution 2015-10, Fiscal Sponsorship Administrative Fees

Chairman Sauble reviewed Resolution 2015-10 for the Fiscal Sponsorship Administrative Fees. Commissioner Newton stated if a grant has one disbursement and is a small amount the maybe charge \$500.00 or less.

The Commission agreed on the following fiscal sponsorship administrative fees:
\$0- \$50,000- one or two disbursements no charge
\$50,001-\$100,000- 0.50% with no disbursement charge
\$100,001-\$500,000- 1.00% plus \$100 per disbursement
