

## TOWN OF SPRINGER

ORDINANCE No. 356

AN ORDINANCE CONSENTING TO THE ANNEXATION OF TERRITORY CONTIGUOUS TO THE TOWN OF SPRINGER WITHIN SECTIONS 16 AND 17, TOWNSHIP 25 NORTH, RANGE 22 EAST, NMPM, MAXWELL GRANT, COLFAX COUNTY, NEW MEXICO

WHEREAS, the owners of a majority of the number of acres in the territory proposed for annexation have petitioned the governing body to annex the territory to the Town of Springer pursuant to the petition method of annexation provided for in NMSA 1978, § 3-7-17; and

WHEREAS, the map submitted to the governing body along with the petition shows that the territory proposed to be annexed is surrounded by property owned by the State of New Mexico and is otherwise contiguous to the Town of Springer, as provided for in NMSA 1978, § 3-7-4(B); and

WHEREAS, the governing body finds that said petition is in order and complies with law in all respects, and that the annexation of said territory would be in the best interests of the Town of Springer.

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF SPRINGER:

**Section 1.** The Town of Springer is the owner of the territory described in Section 2 and has petitioned the governing body to annex the territory to the Town of Springer. The petition is accompanied by a map, a copy of which is attached to this Ordinance as Exhibit "A," which shows the external boundary of the territory proposed to be annexed and the relationship of the territory to the existing boundary of the Town of Springer. Pursuant to the terms of NMSA 1978, § 3-7-4(B), the territory is deemed to be contiguous to the town since it is separated from the town by land owned by the State of New Mexico.

**Section 2.** The governing body consents to the annexation to the Town of Springer of all of that property shown on the plat attached hereto and incorporated herein by reference for all purposes as Exhibit "B" and filed of record with the Office of the Colfax County Clerk on July 6, 2011, Document Number 201101887, and more particularly described as follows:

Tracts A and B, Town of Springer Reservoirs, Situate Within Projected Sections 16 & 17, T.25N., R22E., NMPM., Maxwell Land Grant, City of Springer, Colfax County, New Mexico, together with all roads adjacent to the territory.

**Section 3.** Upon approval, the town clerk shall cause a copy of the Ordinance together with the plat to be filed in the Office of the county Clerk of Colfax County, New Mexico.


**Section 4.** Upon approval, the town clerk shall cause a copy of this Ordinance together with the plat to be sent by the town clerk to the Secretary of the New Mexico Department of Finance and Administration and to the Secretary of the New Mexico Department of Taxation and Revenue.

**Section 5.** The annexation shall be deemed complete for all purposes upon filing of the Ordinance together with the plat in the Office of the Colfax County Clerk.

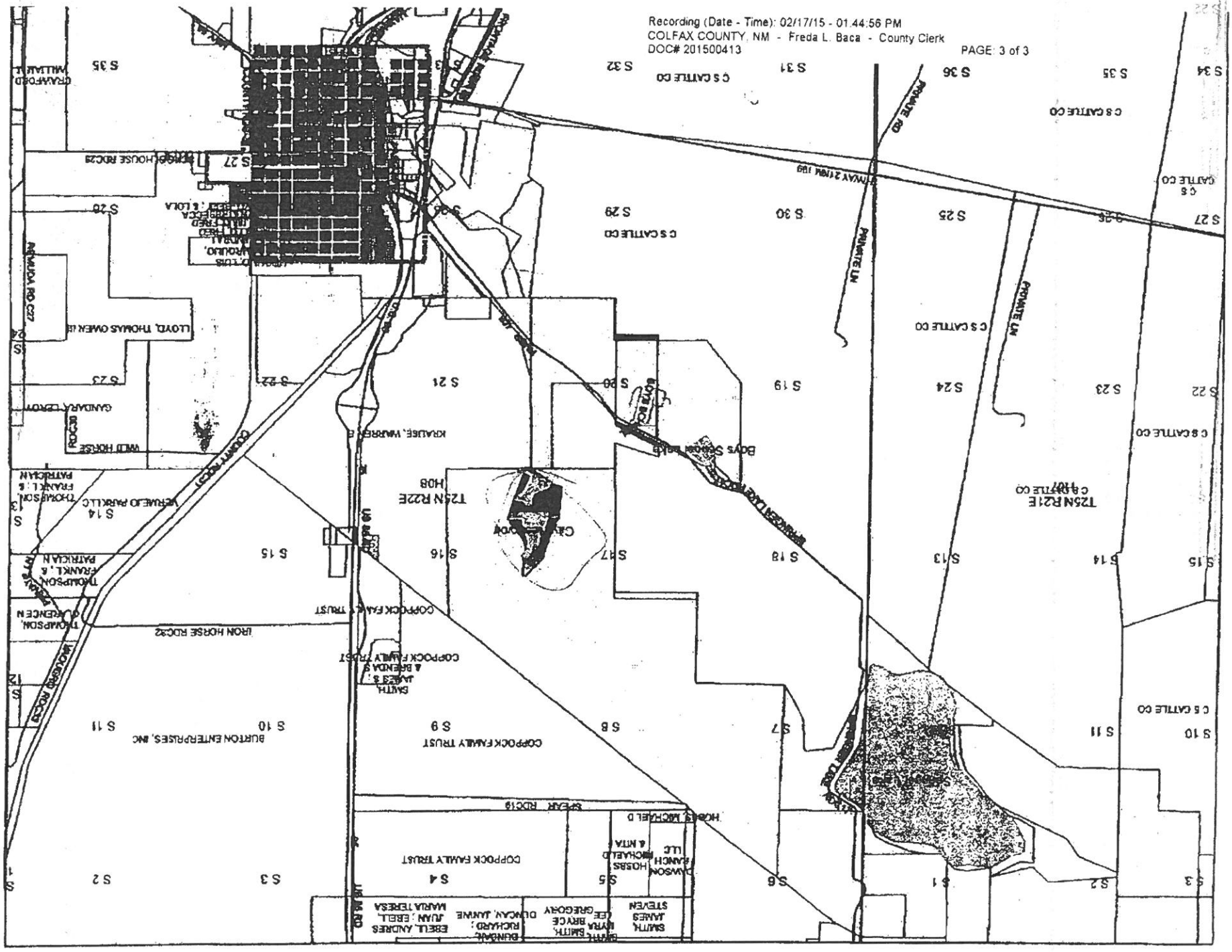
**Section 6.** This Ordinance shall become effective five (5) days following publication after adoption.
