RESOLUTION 2015-18

VIGIL-MALDONADO DETENTION CENTER FEES

WHEREAS, the number of inmates committed and discharged to and from Vigil-Maldonado Detention Center continues to increase and requires additional administrative and personnel resources;

WHEREAS, a booking fee is in effect in a number of county jails/detention centers in New Mexico;

WHEREAS, the Detention Center Administrator has requested that the Board of County Commissioners of Colfax County authorize the implementation of a twenty dollar (\$20.00) booking fee for committing and discharging inmates to and from the county detention center as well as 100% of all medical charges for municipal inmates; and

WHEREAS, the number of inmates committed to Vigil-Maldonado Detention Center continues to increase and requires additional administrative and personnel resources; and

WHEREAS, a housing fee is in effect in a number of county jails/detention centers in New Mexico; and

WHEREAS, the Detention Center Administrator has requested that the Board of County Commissioners of Colfax County authorize the increase to seventy-five dollars (\$75.00) a day for housing inmates at the county detention center for all agencies placing the prisoner in the custody of Vigil-Maldonado Detention Center with the exception of Raton Police Department; and

WHEREAS, the Detention Center Administrator has requested that the Board of County Commissioners of Colfax County authorize Raton Police Department to pay forty-five dollars (\$45.00) a day for housing inmates at the county detention center when placing the prisoner in the custody of Vigil-Maldonado Detention Center;

THEREFORE, BE IT RESOLVED THAT:

1. Resolution #2014-12 replaces previous resolution #2007-41, pertaining to detention center fees.
2. The Board of County Commissioners of Colfax County authorizes the Detention Center Administrator to implement a reasonable booking fee, not to exceed twenty dollars (\$20.00) for committing and discharging of

inmates to and from the Vigil-Maldonado Detention Center where, such fee shall be collected directly from any and all inmates at the time of commitment, as well as 100% of all medical charges for municipal inmates.

- 3. The Board of County Commissioners of Colfax County authorizes the Detention Center Administrator to implement a reasonable increase in the housing fee, not to exceed seventy-five dollars (\$75.00) a day for housing of convicted inmates at the Vigil-Maldonado Detention Center; where, such fee shall be collected from the agency placing the prisoner in the custody of Vigil-Maldonado Detention Center with the exception of Raton Police Department.
- 4. The Board of County Commissioners authorizes Raton Police Department to pay forty-five dollars (\$45.00) a day for housing of convicted inmates at the Vigil-Maldonado Detention Center where such fee shall be collected from Raton Police Department when placing the prisoner in the custody of Vigil-Maldonado Detention Center.
