RESOLUTION NO. 2015-31

A RESOLUTION OF THE COLFAX COUNTY COMMISSION FOR THE DESIGN OF THE ANGEL FIRE AIRPORT TAXIWAY EDGE DRAIN INSTALLATION AND ACCESS ROAD RECONSTRUCTION

WHEREAS, Colfax County, New Mexico owns and operates the Angel Fire Airport for the service and benefit of the community; and

WHEREAS, the airport facility and improvements may be funded from granted revenue sources; and

WHEREAS, grant funding is available from the Federal Aviation Administration (FAA) and the New Mexico Department of Transportation Aviation Division for airport related capital improvements; and

WHEREAS, the County will apply for FAA New Mexico Department of Transportation Aviation Division grant funds for the taxiway edge drain installation and the access road reconstruction; and

THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, COLFAX COUNTY, NEW MEXICO AS FOLLOWS:

Section 1. That the Board of County Commissioners, Colfax County, New Mexico does hereby authorize submittal of a grant applications to FAA and the Department of Transportation Aviation Division; and

Section 2. That the Board of County Commissioners, Colfax County, New Mexico does hereby authorize executing and submitting all documents pertaining to the grant offer as may be required and does authorize the Chairman, Bill Sauble, to accept a grant offer from the FAA and the New Mexico Department of Transportation Aviation Division derived from the applications, and hereby commit to enter into a binding agreements as specified in the grants.

Section 3. All acts and resolutions in conflict with this resolution are hereby rescinded, annulled and repealed.

Section 4. This resolution shall take effect immediately upon its adoption.
