RESOLUTION #2015-36

REPEAL AND REPLACE RESOLUTION #2011-43, DESIGNATING THE POLLING PLACES OF EACH PRECINCT FOR THE 2016 PRIMARY AND GENERAL ELECTIONS

WHEREAS, Section 1-3-2 NMSA 1978 requires that the County Commission, no later than the first Monday in November of each odd-numbered year, adopt a resolution designating the polling place of each precinct that shall provide individuals with physical mobility limitations unobstructed access to at least one voting machine, and

WHEREAS, Section 1-3-4 NMSA 1978 grants counties the ability to consolidate polling places. These consolidated polling places are referred to as Voter Convenience Centers (VCC) which allow registered voters of Colfax County to vote at any designated Voter Convenience Center, and

Now therefore, The Board of Commissioners of County of Colfax New Mexico Hereby Resolves That, this authorizing resolution finds that consolidation will make voting more convenient and accessible to voters of the consolidated precinct and does not result in delays for voters in the voting process and the consolidated precinct voting location will be centrally located within the consolidated precinct; and

IT IS HEREBY FURTHER RESOLVED THAT, the Voter Convenience Centers designated for the 2016 Primary and General Elections which shall provide individuals with physical mobility limitations unobstructed access to at least one voting machine are designated below:
