RESOLUTION 2015-40

Donation of Vehicles to Village of Maxwell, Village of Eagle Nest and Village of Cimarron

WHEREAS, the Colfax County Senior Center no longer needs a 2004 Chevrolet Astro Van, VIN: 1GNEL19X94B119606, mileage 94,566 as the Colfax County Senior Center has another newer vehicle available for the same purpose; and

WHEREAS, the Village of Eagle Nest has a need and will accept this vehicle; and

WHEREAS, the disposition of property by donation to another local governing body is authorized under New Mexico Statute 13-6-1 (D), NMSA 1978; and

WHEREAS, the Colfax County Road Department no longer needs a 1990 Chevrolet Truck, VIN: 2GCEK14H9L11397998, mileage 79,258 for road operation as the Colfax County Road Department has another newer vehicle available for the same purpose;

WHEREAS, the Village of Maxwell has a need and will accept this vehicle; and

WHEREAS, the disposition of property by donation to another local governing body is authorized under New Mexico Statute 13-6-1 (D), NMSA 1978; and

WHEREAS, the Colfax County Philmont Fire District no longer needs a 1983 Chevrolet Van, VIN: 2GCFG31M8D4111400, mileage 2,682 for fire-fighting functions as the Colfax County Philmont Fire District has another newer vehicle available for the same purpose; and

WHEREAS, the Village of Cimarron has a need and will accept this vehicle; and

WHEREAS, the disposition of property by donation to another local governing body is authorized under New Mexico Statute 13-6-1 (D), NMSA 1978; and

WHEREAS, Colfax County will request permission from New Mexico Department of Finance for permission to donate the 1983 Chevrolet Van, VIN: 2GCFG31M8D4111400, mileage 2,682, since this vehicle was purchased with State Fire Funds; now

THEREFORE, BE IT RESOLVED, that the Board of County Commissioners of Colfax County, New Mexico, hereby approves, authorizes and directs that Colfax County transfer and donate the referenced vehicles to the specified New Mexico municipalities upon receipt of approval from New Mexico Department of Finance where indicated.
