WHEREAS, the Miami Fire Department Fund (209-0406), the Philmont Fire Fund (209-0409), the Moreno Valley Fire Fund (209-0410) and the Northeast District 8-Rapid Response Fire Fund (209-0419) have sufficient funds; and

WHEREAS, in November 2015, the Philmont Fire Fund (209-0409) received \$100,000 from the New Mexico Fire Protection Fund, and the Northeast District 8-Rapid Response Fire Fund (209-0419) received \$80,000 from the New Mexico Fire Protection Grant Fund; and

WHEREAS, funds have and need to be expended for the each of the above listed funds; and

WHEREAS, budget increases under such circumstances is necessary and lawful, the following budget increases should be made as follows:
