RESOLUTION 2017-09

Solid Waste Fee - FY 2017

WHEREAS, Colfax County regulates the collection and disposal of refuse (Solid Waste) for the health, safety and welfare of the public; and

WHEREAS, Colfax County is authorized to establish, assess and collect fees to pay the necessary costs of a refuse collection and disposal system pursuant to §4-56-3, NMSA 1978 and Colfax County Ordinance 2015-04; and

WHEREAS, Colfax County Commissioners have reviewed Solid Waste Revenues and Expenses for FY 2017 and has determined a fee increase is necessary for FY 2017;

THEREFORE, BE IT RESOLVED, that the Board of County Commissioners of Colfax County, New Mexico, hereby, authorizes the annual Solid Waste Fee for FY 2017 of \$210.00 (including gross receipts tax) for all Colfax County persons, businesses and residences within Colfax County, excluding those within the boundaries of municipalities; and

BE IT FURTHER RESOLVED, that all commercial properties or residences that maintain dumpsters for private use only be charged \$70.00 per month per dumpster plus gross receipts tax.

BE IT FURTHER RESOLVED, that the Board of County Commissioners of Colfax County, New Mexico, hereby, authorized the following collection process:

Bills for Solid Waste Management fee are mailed quarterly, in advance. The following is the billing and collections timeline, with the date of billing being "X".

X plus 60 days	Reminder billing sent to all unpaid accounts
X plus 90 days	Second reminder bill sent to all unpaid accounts
X plus 105 days	1.5% late fee assessed monthly; Bills are stamped, "PAST DUE"
X plus 120 days	"PAST DUE" letter sent
X plus 150 days	"SERIOUS PAST DUE" letter sent
X plus 170 days	1.5% late fee assessed monthly; "LIEN LETTER" sent certified mail, the account charged for certified postage
X plus 210 days	Lien filed with the account charged for lien filing fee. Copy of filed lien sent via regular mail after year 2 of billing.
